This article compares British and U.S. approaches to the human right to transportation. According to the author, research has identified a significant minority of poor people who are restricted in use of transport because of low incomes, or fear of crime, or due to physical or mental disabilities or simply because public transportation services do not take these people where they need to go and they do not have access to a car. The author claims that perhaps the accessibility planning approach of Great Britain has something to offer to U.S. colleagues in terms of establishing a systematic process for the assessment of transport poverty.
